### Change to 10.7:

10.7 Divisional Play Structure: Placement of teams in each separate age and gender grouping shall be determined using the following criteria.

- B) Category 1 associations - Category 1 association towns shall be defined as a minimum of (6) town associations that possess the highest **total performance score** ~~average number of teams placed~~ in each specific age and gender grouping over the 3 prior SSSL spring seasons. **The total performance score calculation is as follows: = {(Points \* [Division factor (3 or 2 or 1)]) + [Count weighted by Division (5 or 3 or 1)]} \* Recent Factor (100% or 75% or 50%).**
